## **GENERAL ASSEMBLY UPDATES**

#### Worker Freedom of Speech

Tomorrow, Wednesday March 6, the IL AFL-CIO's priority legislation, Worker Freedom of Speech (SB3649) is expected to be heard in the Senate Labor Committee.

Senate Bill 3649, sponsored by Labor Chair Sen. Robert Peters, protects employees if they refuse to attend employer sponsored meetings on religious or political speech. This anti-captive audience legislation will protect employees from unwanted religious or political speech, which includes captive audience meetings.

We know these meetings are a vicious union-busting tactic and the likelihood of winning an organizing campaign can drop significantly when employers engage in these unscrupulous behaviors. When the bill becomes law, it will protect all workers from being forced to participate in these conversations and allow them to walk away without fear of retaliation or losing their job.

The biggest impact you can have today to help pass this key legislation is by filling out a witness slip. Can you tell the Senate Labor Committee that worker freedom of speech needs to be the law of the land in Illinois?

- 1. Go to SB 3649 (Employee Freedom of Speech) and click create a witness slip.
- 2. Fill out your name, union hall address, union local and phone number.
- 3. For Sec. II (Representation) fill in your CLC or local union.
- 4. Sec. III Select Proponent
- 5. Sec. IV Select Record of Appearance Only
- 6. Agree to the terms and conditions and submit!
